

**Amargosa Days Solar Cook-off Event**

The Amargosa Valley Chamber of Commerce is organizing our annual town celebration. Amargosa Days will be held Saturday, April 16, 2011.

Solar Millennium is sponsoring a Solar Hot Dog Cook-off event. The event will be divided into two categories, kids & adults. The teen category is open to participants age 13 to 17 or any teen currently enrolled in any high school program approved by the Nye County School District. The adult category is open to participants ages 18 and up. First Place prize is \$125 for each category. Second Place prize is \$75, and the Third Place prize is \$25. The event will start at 2:00 pm.

Each entry will be judged by a three-judge panel. Entrants will be allowed 2 hot dogs, with a starting internal temperature of 50 degrees f or less. Each cooking appliance must cook one hot dog to a minimum internal temperature of 160 degrees within 10 minutes. Entries will be judged primarily on speed and appearance, and secondarily on the use of technology. Each entry will be checked using a standard meat thermometer.
